

Matilda Jane

1. Our 435 Art Fair is Saturday June 25th from 9am to 4pm.
2. All items are non-exchangeable and non-returnable.
3. We are unable to except any returns/exchanges from previous Art Fair, Platinum, or Trunk Show purchases at this Art Fair.
4. Matilda Jane gift cards are not accepted at the Art Fair. We accept cash, check, Visa, Mastercard and Discover only.
5. The family friendly Pre-Party will be on Friday June 24th from 6pm to 9pm. You must have RSVP'd for this Pre-Party and must have your **Pre-Party admission ticket** with you (tickets to be mailed out early June).
6. The Adults Only Post-Party will be held on Saturday June 25th from 7pm to 10pm. You must have RSVP'd for this Post-Party and must have your **Post-Party admission ticket** with you (tickets to be mailed out early June).
7. We will not be limiting the dollar amount spent at the 435 Art Fair, however we will limit the quantity of items per size and style that you can buy in order to allow as many customers as possible to enjoy Matilda Jane. (See #8)
8. You are allowed to buy **only 1 per size** of each style, but cannot exceed 3 purchases per style.

***Example:** You can buy one size 2, one size 4, and one size 6 of a particular Molly skirt, but once you have purchased those three pieces, you have reached the maximum allowed for that specific Molly skirt.*

9. Matilda Jane reserves the right to turn down a sale that we feel is for the purpose of “re-selling”.
10. We will have a few “sorting tables” set up for convenience, but please understand that we reserve the right to limit the amount of inventory you are “sorting through”. If you are “holding” too much inventory, a Matilda Jane employee or on-site security officer may ask you to relinquish some of your inventory.
11. **All items are sold as-is. All sales are final.** (See #2)
12. If you are buying for a friend and are using her credit card, we will need a photocopy of the front and back of the card. We will also need the Credit Card Authorization Form filled out completely by the card holder. See form on page 2. **THIS FORM MUST BE FILLED OUT COMPLETELY BY THE CARD HOLDER AND PRESENTED AT TIME OF PURCHASE.**

Our parking lot will not be available for parking the day of the Art Fair.
